MMI testing will be conducted in **July 2024**. Applicants must be available for MMI testing.

All applicants will be notified by email in August 2024 regarding their admission status. Accepted candidates will attend an orientation and registration session on **Tuesday**, **August 27**th, **2024**.

ADMISSIONS POLICY

GENERAL

- Start the application process early. Please allow 2 months to complete Criminal Record Check and Child & Adult Abuse Registry Checks.
- All required documents must be received before applicants will be considered for MMI testing or entered into the application process.
- The Primary Care Paramedic Program has a competitive selection process based on a candidate's application and performance on our multiple mini interviews and testing selection process. Criti Care does not maintain a waitlist for acceptance into the Paramedic Program. We will accept applications until the posted application deadline, then interview and test those applicants who have submitted all required documents and meet all pre-requisites.
- The Primary Care Paramedicine Program is taught at a university level, therefore it is incumbent upon the applicant to understand that the minimum qualifications set out herein reflects the academic background which we believe necessary to complete the program. Successful completion of this program requires meeting a high academic standard, successful field precepting, coupled with aptitude, diligent study, and effort.
- The in person didactic (classroom) portion of the course will run from September 2024 until approximately July 2025. The ambulance and hospital practicum portion will run from approximately July 2025 until December 2025. Graduation from the PCP program will tentatively be in December 2025.

APPLICATION CRITERIA

Education -

- High school
 - o One senior level credit in Chemistry or Physics (Grade 11 or Grade 12)
 - o One senior level credit in English (Grade 11 or Grade 12)
- Post Secondary
 - 6 credits of Post-Secondary Human Anatomy & Physiology (including a lab component) completed within the last five years. (Please see page 12 of the application for more information)
- Please also submit any recognized post-secondary education
- Manitoba Class 4 Driver's license
- Original Copy of Criminal Record Check (dated within 12 months of application)
- Original Copy of Adult and Child Abuse Registry Check (dated within 12 months of application)
- Handwritten Autobiographical Letter (see instructions below)
- Current certification (within the last 12 months) for BLS Level CPR
- Current certification (within the last 12 months) for First Aid (Emergency, Standard or Advanced First Aid)
- Confirmation of Immunizations including confirmation of full vaccination for Covid-19 (record of immunization).
- Canadian Citizen or Permanent Resident.

INSTRUCTIONS FOR AUTOBIOGRAPHICAL LETTER

Autobiographical letter (2 pages, single spaced) outlining why you are choosing to go into paramedicine, how/when you have demonstrated characteristics or attributes such as: commitment, dedication, critical thinking and decision making, accountability, professionalism, conflict resolution, overcoming adversity, public service.

ADDITIONAL SELECTION CRITERIA TO BE CONSIDERED

- Previous Academic Achievements
- Multiple Mini Interviews (MMI Testing) It is a series of mini-interviews / stations, lasting 10 minutes each. The MMI evaluates personal characteristics (non-cognitive attributes) important for success in Paramedicine and health sciences setting including: Ethics, Accountability, Communication, Good Judgment, Critical Reasoning Skills, Empathy, Maturity, Strong Interpersonal Skills. This interview method provides an opportunity for applicants to apply general knowledge and personal experiences to issues relevant to the society in which they live and the health care systems in which they hope to work.

* Students must wear designated Paramedic uniform for all sections of training. Students will be sized for uniforms during the program orientation and registration.

A NOTE REGARDING: CLINICAL PRACTICUM

• Costs associated with travel and accommodations during ambulance internship / clinical practicum will be the responsibility of the student.

All students will be required to have the following for the duration of the program for electronic competency tracking (CompTracker):

• Apple iPad Mini (running the latest iOS version is recommended). An iPad can also be used but the preferred device is the iPad mini

• Android Tablet (Example: Samsung Galaxy Tablet). Android tablets must currently support Android Operating Systems (5.0 or greater).

CLINICAL PRACTICUMS

The Primary Care Paramedicine Program is designed to provide students with a breadth of clinical experience. Students will attend EMS ambulance sites, community EMS sites, as well as Hospital based departments including Emergency Department/Urgent Care and other clinical departments.

Students are afforded the opportunity to experience a wide variety of patient encounters as well as exposure to different EMS system models, including public municipal EMS, private municipal EMS, urban & rural EMS. All EMS field precepting takes place in services with which we have precepting and training agreements, including in Winnipeg and rural Manitoba.

Physical Fitness Assessment and Counseling

ONCE YOU HAVE BEEN ADMITTED INTO THE PARAMEDICINE PROGRAM, YOU WILL BE REQUIRED TO COMPLETE A PHYSICAL FITNESS ASSESSMENT AT THE UNIVERSITY OF MANITOBA.

Note this assessment will be scheduled AFTER you are accepted into the Program. The following is provided for information only:

Paramedic Physical Fitness Assessment

Policy and Procedure:

A Paramedic Job Related Physical Fitness Assessment is done as part of the Criti Care EMS Primary Care Paramedic Program Enrolment. The testing is done by the University of Manitoba Faculty of Kinesiology and Recreation Management. All students enrolled in the Paramedic Program must complete the testing and return a copy of the completed testing certificate to Criti Care EMS. The testing is done for counseling purposes related to suitability for a career as a Paramedic. The university will provide counseling in any tested area that candidate has not demonstrated satisfactory performance in to allow the candidate to improve their abilities. Please note in order to proceed to clinical practicum the job related physical testing must be completed with a pass.



CRITI CARE PRIMARY CARE PARAMEDICINE PROGRAM ANATOMY & PHYSIOLOGY PREREQUISITE INFORMATION

The College of Paramedics of Manitoba (CPMB) requires PCP Program applicants to have completed 6 credit hours in Anatomy and Physiology from a post-secondary institution prior to admission to a Paramedicine Program.

Please note that we can only accept the **Athabasca University** BIOL 235 Human Anatomy and Physiology (6 credits) (online course *without* a lab component) for those students who were enrolled in it **PRIOR to March 31**, **2024**.

Similar courses (or combinations of courses) from other government-approved post-secondary institutions will also be considered – contact our office to enquire.

Note: The College of Paramedics of Manitoba may issue exemptions to this prerequisite for individuals that meet specific criteria (for example previous education, training and related healthcare experience) – view the CPMB policy online and contact the CPMB directly for information regarding obtaining an exemption for the A&P prerequisite.
